ACADEMIC PROGRAM

Customize your degree progression with opportunities for specialization, joint degree programs, and flexible scheduling options.

Full- and part-time programs are available with start dates in August. Students must complete 89 credits to graduate. In addition to a variety of required courses, you may also select from a broad range of upper-level and elective courses, including substantive law courses, legal clinics, simulation courses, and field placements.

Full-Time

Earn a J.D. in three years. Full-time students take 15 credit hours during the fall and spring semesters and complete required courses by the end of their first year. Students typically complete their course of study in six semesters and may graduate early by taking optional summer course work.

Part-Time

Earn a J.D. at your own pace. Part-time students typically take 8-10 credit hours per semester. Courses are available for the fall and spring semesters and optional summer session.

ACADEMIC SUCCESS AND BAR PASSAGE

Cultivate success with Toledo Law's Academic Success Program to support you in the classroom and Bar Passage Program to prepare you for the bar exam.

Academic Success Program

Seminars

During your first semester, you will attend seminars focused on reading and understanding cases, case briefing, outlining, and preparing for exams to increase your skills and confidence.

Teaching Assistants

Each of your first-year courses will have an upper-level law student as a teaching assistant.

Academic Advising

You will be matched with a faculty advisor who assists with course planning and academic goal setting throughout your law school experience.

Advanced Legal Analysis Course

Toledo Law supports your academic success. If your first-semester GPA is lower than 2.3, you will take a second semester course with additional training in study skills, legal reasoning, and test taking.

Bar Passage Program

Bar Exam Preparation Course

As a third-year student, you may enroll in a for-credit bar preparation course with substantive topic outlines, practice questions, and simulated bar essays.

Bar Review Course

You will have access to a bar review course at the completion of your law school experience as well as bonus materials to help you through first year and upper level courses starting in your first semester.

Subject-Area Review Lectures

In the weeks leading up to the bar exam, access short, focused lectures from our professors to review and solidify your knowledge.

Post-Graduation Mentoring

You will be assigned a faculty mentor to provide personalized support during your bar exam study.

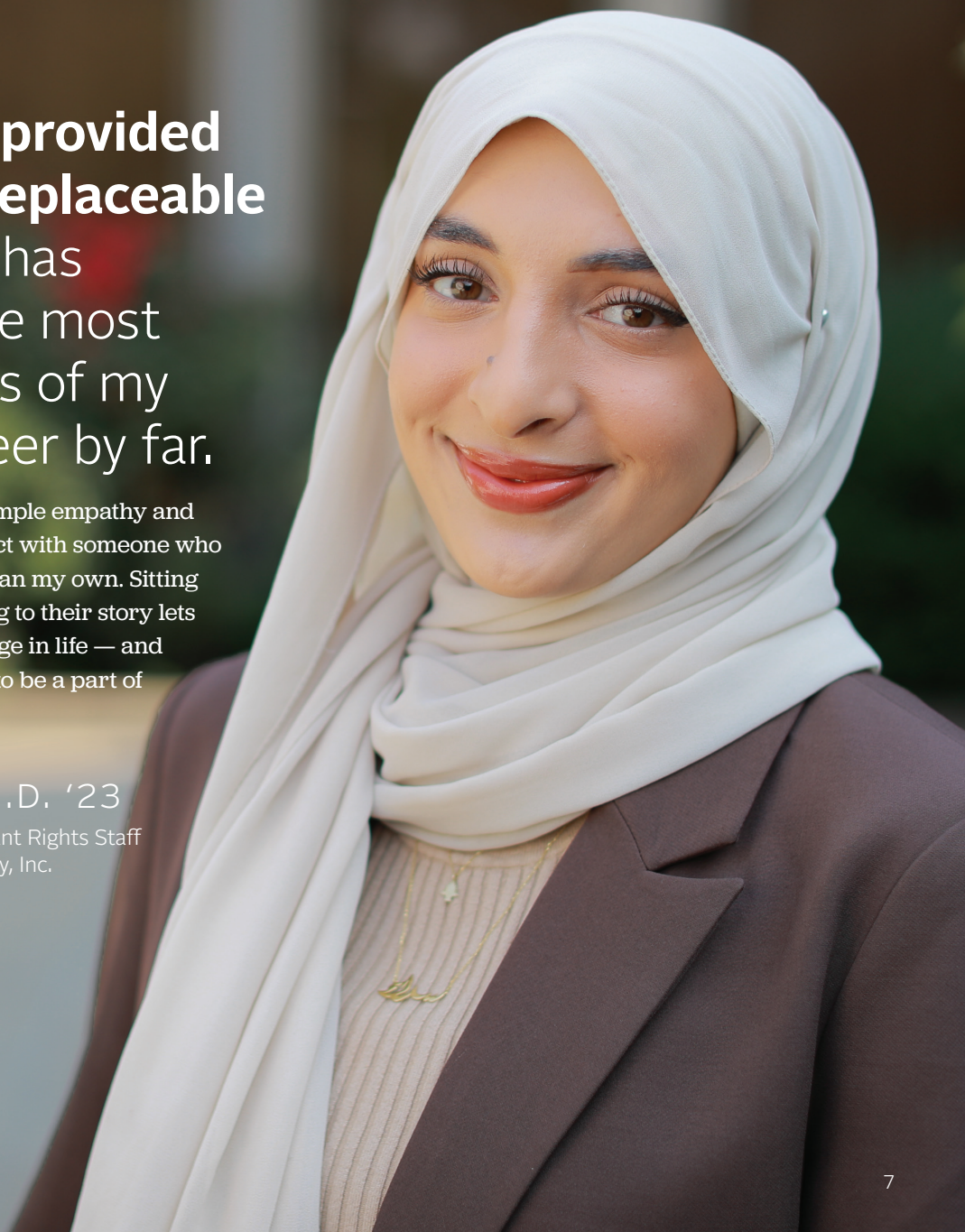

LEGAL CLINICS AND EXTERNSHIPS

Our clinics and externships let you hone your skills while providing high-quality legal services to individuals and groups in our community. Learn practical and professional skills in a supervised setting as you explore the role of a practicing attorney, prosecutor, judge, or mediator. Reap the benefits of a rigorous and dynamic educational experience where you learn by doing.

Instruction in the college's clinics includes small classes and direct supervision from clinical professors actively engaged in the practice of law. Externships provide you with greater insight into the workings of the legal system.

- **Civil Advocacy Clinic** — Gain experience in civil (or non-criminal) areas of legal practice and advocacy, including interviewing, counseling, research, discovery, negotiation, pleading and motion practice, alternative dispute resolution, court appearances, trial preparation and practice, and appeals.
- **Immigrant Justice Clinic** — Represent local community members with critical legal needs working through the U.S. immigration system.
- **Tax Controversy Clinic** — Assist taxpayers handling disputes with the Internal Revenue Service (IRS), including audits, appeals, and collection matters.
- **Corporate Counsel Externship** — Explore the work of corporate counsel within for-profit and nonprofit businesses, including contract review, real estate transactions, securities law, negotiations, and corporate compliance. Students will be placed in corporate counsel offices in Northwest Ohio and beyond to complete this externship.
- **Public Service Externship** — Learn about the responsibilities of public service attorneys within courts, government agencies, and nonprofit organizations. Students are placed in public service offices in Northwest Ohio and beyond to complete this externship.
- **Mediation Externship** — Train as a mediator and conduct mediations in local court systems to help parties resolve disputes outside of litigation.

The development of professional skills is integral to your success as a practicing attorney. At Toledo Law, you will take six credit hours of experiential learning courses in clinics, externships, or simulation courses.

Pro Bono Opportunities

You'll have the opportunity to help meet the need for low or no-cost legal services in our community. Toledo Law will help you find placements with area organizations, such as the Toledo Bar Association Pro Bono Legal Services Program, Legal Aid of Western Ohio, and Advocates for Basic Legal Equality. You can earn a Public Service Commendation during each semester you perform 30 or more documented hours of unpaid, law-related service work.

Simulation Courses

Toledo Law offers a wide variety of experiential learning courses providing substantial instruction in professional skills, which are essential to your success as a practicing attorney. Simulation course examples include Trial Practice, Constitutional Litigation, Criminal Law Simulation, Employment Law Drafting, Negotiation Theory and Strategy, and Pretrial Litigation.

OPPORTUNITIES FOR UPPER-LEVEL STUDENTS

Lawyering skills and professionalism are emphasized from the outset of your education at Toledo Law. The opportunities to gain real-world legal skills in writing and oral advocacy also expand after your first year.

Law Review

Law Review is a scholarly publication devoted to current legal issues. Each issue contains articles by legal scholars and practitioners, comments by students about new developments in the law, and discussions by students on recent noteworthy cases. Law Review hosts a symposium each fall. Recent symposia have addressed the opioid crisis, sentencing policies and practices, election law, gender equality, and technology.

Moot Court

The Moot Court program gives you the opportunity to practice your written and oral advocacy skills in mock appeals cases. Students travel to competitions nationwide to test their skills against other law school teams. Moot Court includes teams devoted to criminal law, labor and employment law, intellectual property law, constitutional law, and products liability law.

Mock Trial Team

Students on the Ohio Attorney General's Mock Trial Team compete in an annual trial competition. Students gain exposure to every facet of a trial: they argue pretrial motions and evidentiary issues, deliver opening and closing arguments, and perform direct and cross examinations of witnesses. A sitting judge presides, and a jury of practicing attorneys assesses the presentation.

Trial Advocacy

Trial Advocacy provides the opportunity to engage with the performative aspects of practicing the law and develop skills in teamwork, collaboration, and camaraderie. In the spring semester, Trial Advocacy hosts a competition for any Toledo Law student to participate in. Legal professionals in the Toledo community participate and serve as judges.

Charles W. Fornoff Appellate Advocacy Competition

This annual competition enables you to develop skills required for effective oral advocacy. The tournament culminates with a final round in the McQuade Law Auditorium packed with faculty, family members, and peers. The final panel of judges typically includes federal judges and state justices.

Symposia and Conferences

You will engage distinguished members of the legal community in symposia and national conferences at the Law Center. The annual Great Lakes Water Conference addresses legal and policy issues critical to the environment. Our speaker series and lectures spotlight legal opinion leaders and connect you with attorneys who recently argued cases before the U.S. Supreme Court.

National Honor Societies

Order of the Coif

Honor society for top graduates at select law schools. Students must earn their J.D. and graduate in the top 10% of their class to be eligible for membership.

Order of Barristers

Honorary organization that encourages oral advocacy and brief-writing skills. Students who excel in advocacy and service are eligible for membership.

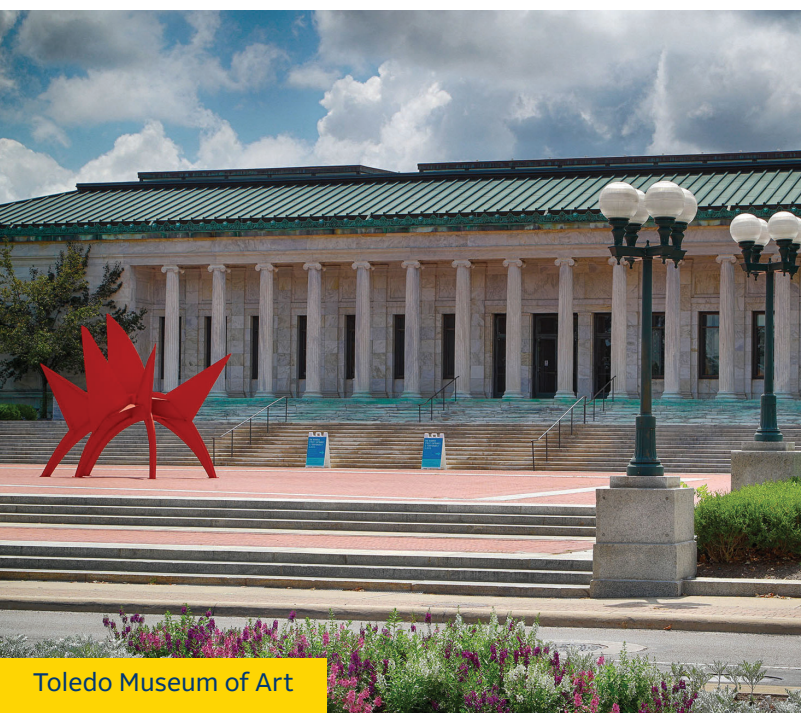


ABOUT THE TOLEDO AREA

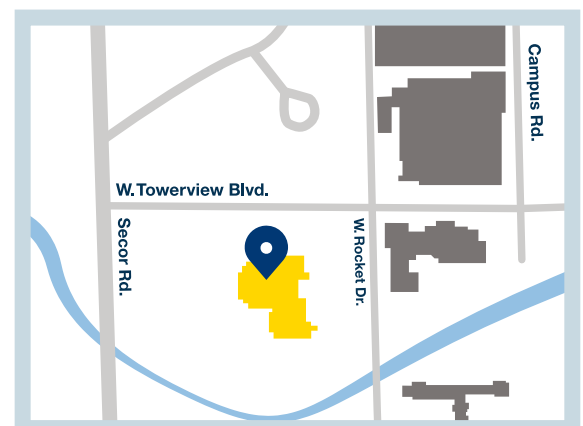
